<ul style="list-style-type: none"> <li>• Staff and children advised to wear appropriate clothing, children will be directed to come in PE kits.</li> <li>• Staff and children advised to bring a hat to wear outdoors- wide brimmed will be encouraged</li> <li>• Staff and children encouraged to stay hydrated- water is available throughout the school, all children asked to bring a refillable bottle, spares and cups are available</li> <li>• Staff and children to wear high factor sun protection and to reapply throughout the day</li> <li>• Lunch and break times reduced, shaded areas to be used</li> <li>• No PE sessions to prevent exertion</li> <li>• Lights in classrooms to remain off</li> <li>• Use of electrical equipment to be minimised to strictly necessary use only</li> <li>• Electrical fans not to be used if temperature exceeds 35 degrees</li> <li>• Staff advised to ensure cars are safe to travel in and take water in case of breakdowns</li> <li>• Parents invited to attend events, we will ensure all activities are in the shade and expect temperatures to have reduced by the time we are inviting parents to attend.</li> <li>• Gates opened promptly to allow for ease of collection.</li> <li>• Trips will be risk assessed on a daily basis, depending on risk assessments of venues also.</li> <li>• Measures are shared with parents via text and social media</li> </ul>
